We are committed to serving you with the utmost regard for your family. This price list reflects our commitment to provide consumer information to those that we are privileged to serve. The goods and services show below are those we can provide to our customers. You may choose only the items that you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected. **DUE TO THE COVID PANDEMIC, TIME FRAMES MAY BE EXTENDED DUE TO DELAYS OUTSIDE OUR CONTROL.**

### **Basic Services of Funeral Director and Staff Overhead.....\$2,495**

Our services include: conducting the arrangement conference; planning the funeral; consulting with family and clergy; shelter of remains; preparing and filing of necessary notices; obtaining necessary authorizations and permits; coordinating with the cemetery, crematory, or other third parties. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for Direct Cremations, immediate burials, and forwarding or receiving remains. The fee is also included in our charges for Platinum Burial, Traditional Burial, Veteran's Burial, Traditional Cremation, Memorial Cremation, Veteran's Cremation, and Concierge Cremations.)

### **Embalming .....\$995**

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as a Direct Cremation or Immediate Burial.

### **Forwarding Remains to another Funeral Home.....\$1,395\***

Our charge includes: basic services of Funeral Director and staff, removal of remains, embalming or other preparation of remains (if relevant), shipping container and transportation to local airport or other place of shipment within 30-mile radius (EXCLUDES shipping charges and, if necessary, shipping container and tax on shipping container). This charge does NOT include any funeral services or visitation. *This charge applies to shipment within the United States only (Includes Hawaii & Alaska).* \*(\$1,995 for International Forwarding – NOT including: shipping charges, shipping container & tax, casket & tax, Consulate/Translation fees, Viewings or Services)

### **Receiving Remains from another Funeral Home.....\$995**

Our charge includes: basic services of Funeral Director and staff and transportation from local airport or other shipping destination with 30 mile radius. (This charge does NOT include any funeral services or visitation.)

### **Direct Cremation.....\$775 to \$5,770**

Our charge for Direct Cremation (without ceremony) includes: basic services of Funeral Director and staff, a proportionate share of overhead costs, removal of remains (within 30 mile radius), refrigeration, transportation to the Crematory and the Crematory fee, arrangement conference at McDermott's or by phone with the necessary documents being sent via email to the Legal Next-of-Kin/Representative for electronic signatures and initials, plus the temporary plastic container. This charge does include the necessary authorizations. It DOES NOT include any funeral services, visitation, ID Viewing, Death Certificates, or \$10 State Funeral Board fee. If you want to arrange a Direct Cremation, you can use an Alternative Container. Alternative Containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The container we provide is a cardboard container suitable for identification purposes. No Discounts available with Direct Cremation.

Our charge for Concierge Cremation (Direct Cremation without ceremony) includes: basic services of Funeral Director and staff, a proportionate share of overhead costs, removal of remains (within 30 mile radius), refrigeration, transportation to the Crematory and the Crematory fee, arrangement conference at residence of legal Next-of-Kin or their representative (arrangement conference will take place at McDermott's if requested) or by phone with the necessary documents being sent via email to the Legal Next-of-Kin/Representative for electronic signatures and initials, the temporary plastic container (or filling whatever appropriate urn(s)/jewelry provided by family)processing/ordering/delivery of Certified Death Certificates (1 included),one (1) ID Viewing (if requested), and delivery of cremated remains and Death Certificates via USPS Express Mail (within 30-mile radius – regular shipping charges apply outside of radius). This charge includes the necessary authorizations. It DOES NOT include any funeral services or visitation (outside of the one (1) ID Viewing (if requested). If you want to arrange a Concierge Cremation, a rigid Alternative Container must be used. Alternative Containers encase the body and can be made of materials like fiberboard or composite materials (with or without an outside covering). The container we provide is a cardboard container suitable for identification purposes.

Our charge for **MEMORIAL CREMATION** (Concierge Cremation WITH ceremony) includes: basic services of Funeral Director and staff, a proportionate share of overhead costs, removal of remains (within 30 mile radius), refrigeration, transportation to the Crematory and the Crematory fee, arrangement conference at residence of legal Next-of-Kin or their representative (arrangement conference will take place at McDermott's if requested) or by phone with the necessary documents being sent via email to the Legal Next-of-Kin/Representative for electronic signatures and initials, processing/ordering/delivery of Certified Death Certificates (1 included),one (1) ID Viewing (if requested), and local delivery of cremated remains and Death Certificates (Extra charge if mailing Death Certificates is requested as we only mail by Priority USPS Service). This charge includes the necessary authorizations. It also includes funeral services. **TRADITIONAL CREMATION** is a Memorial Cremation PLUS the following: embalming, dressing, cosmetics, rental casket and insert, visitation (outside of the one (1) ID Viewing, if requested) is ONLY available with the Traditional Cremation Package at either McDermott's, MEET Las Vegas\*\*, the family's church, or another appropriate location of the family's choosing (i.e.: their home, an outside event space, etc.) for up to 8 hours (depending on the venue chosen). \*\*MEET Las Vegas services also include: 20 parking passes (NOT available on holidays or if "special events" are scheduled in area), bottled water (1.5 bottles per attendee), projection display (if requested), and door person at venue. Our charge for Traditional Burial includes: basic services of Funeral Director and staff, a proportionate share of overhead costs, removal of remains (within 30 mile radius), refrigeration, arrangement conference at residence of legal Next-of-Kin or their representative (arrangement conference will take place at McDermott's if requested) or by phone with the necessary documents being sent via email to the Legal Next-of-Kin/Representative for electronic signatures and initials, processing/ordering/delivery of Certified Death Certificates (1 included - Extra charge if mailing Death Certificates is requested as we only mail by Priority USPS Service), one (1) ID Viewing (if requested), delivery to, and coordination with, your local cemetery of choice (within 30 mile radius). This charge includes the necessary authorizations. It also includes the following: embalming, dressing, cosmetics, visitation (outside of the one (1) ID Viewing, if requested) which is ONLY available at either McDermott's, MEET Las Vegas\*\*, the family's church, or another appropriate location of the family's choosing (i.e.: their home, an outside event space, etc.) for up to 8 hours (depending on the venue chosen). \*\*MEET Las Vegas services also include: 20 parking passes (NOT available on holidays or if "special events" are scheduled in area), bottled water (1.5 bottles per attendee), projection display (if requested), and door person at venue.
