IF YOU SELECTED A FUNERAL THAT MAY REQUIRE EMBALMING, SUCH AS A FUNERAL WITH VIEWING, YOU MAY HAVE TO PAY FOR EMBALMING. YOU DO NOT HAVE TO PAY FOR EMBALMING YOU DID NOT APPROVE IF YOU SELECTED ARRANGEMENTS SUCH AS A DIRECT CREMATION OR IMMEDIATE BURIAL. IF WE CHARGED FOR EMBALMING, WE WILL EXPLAIN WHY BELOW.

Table III: Special Charges. Lists 11 items such as Ship-OUT, Ship-IN, Cleaning Deposit, Traditional Burial, Traditional Cremation, Memorial Cremation, Concierge Cremation, Direct Cremation, Immediate Burial, USPS Express Mail-Remains, and USPS Priority Mail-Death Certificates.

Table IV: Cash Advanced By Seller. Section A: We charge you for our services in obtaining any item marked with an asterisk(*). Lists 6 items: Death Certificates*, Clergy Honorarium*, Common Carrier*, State Funeral Board Fee, Apostille Fee, and Other Cash Advance*.

Table V: Contract Summary. Summary of charges (Section I-IV), subtotal, payment type, and balance due. Includes a signature line for the purchaser with a warning: Payment - \$500.00 LATE FEE added if, after 30 days, payment is not made IN FULL or an Insurance Assignment isn't approved.
